**A RESOLUTION OF THE GOVERNING BODY OF THE BOROUGH OF FLORHAM PARK,  
COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING AWARD OF A NON-FAIR  
AND OPEN CONTRACT FOR CONSULTING SERVICES TO WILLIAM STOTHOFF COMPANY**

**WHEREAS**, the Borough of Florham Park's Water Utility has a need to revise the non-fair and open contract for well drilling services pursuant to the provisions of N.J.S.A. 19:44A-20.4 and 20.5; and,

**WHEREAS**, the Qualified Purchasing Agent has determined and certified in writing that the value of the acquisition will exceed \$17,500; and,

**WHEREAS**, the anticipated term of this contract is for 2026; and

**WHEREAS**, William Stothoff Company has submitted a proposal on May 7, 2026 indicating they will provide the well drilling services and the compensation is as follows:

Observation, Well Permits and Records	\$ 1,000.00
Mobilization/Demobilization -	\$ 8,000.00
Drilling 2 test wells near well 5 -	\$33,000.00
Construction of Observation Wells	\$10,000.00
<b>Total -</b>	<b>\$52,000.00</b>

**WHEREAS**, William Stothoff Company has completed and submitted a Business Entity Disclosure Certification which certifies that William Stothoff Company has not made any reportable contributions to a political or candidate committee in the Borough of Florham Park, County of Morris, State of New Jersey in the previous one year, and that the contract will prohibit the William Stothoff Company from making any reportable contributions through the term of the contract, and

**WHEREAS**, the CFO has submitted a certification of funds to the Borough Clerk

**NOW THEREFORE, BE IT RESOLVED** that the Governing Body of the Borough of Florham Park, County of Morris, State of New Jersey authorizes the Florham Park Water Utility to enter into a contract with William Stothoff Company as described herein; and,

**BE IT FURTHER RESOLVED** that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution. And,

This Resolution will take effect immediately.
