**A RESOLUTION OF THE GOVERNING BODY OF THE BOROUGH OF FLORHAM PARK,
COUNTY OF MORRIS, STATE OF NEW JERSEY, AUTHORIZING A CONTRACT AWARD
FOR THE 2026 FLORHAM PARK COMMUNITY GARDEN EXPANSION PROJECT TO BEST
GATE AND FENCE OF NJ, INC.**

WHEREAS, there exists a need to enter into an agreement for the 2026 Florham Park Community Garden Expansion Project; and

WHEREAS, the Borough of Florham Park solicited quotes for this purpose; and

WHEREAS, proposals were accepted until 4:00 pm on May 20, 2026, at the Municipal Building, located at 111 Ridgedale Avenue, Florham Park, NJ 07932; and

WHEREAS, bids were solicited to nine contractors and one (1) bid was submitted for the project, which was all reviewed by the Qualified Purchasing Agent and

WHEREAS, administrative and technical reviews by the Qualified Purchasing Agent and the Borough Engineer were performed and **Best Gate & Fence of NJ, Inc.** of **Fairfield, NJ** was deemed the lowest responsible bidder with a total base bid of \$52,870.00.

WHEREAS, Best Gate & Fence of NJ, Inc. has completed and submitted a Business Entity Disclosure Certification which certifies that Best Gate & Fence of NJ, Inc. has not made any reportable contributions to a political or candidate committee in the Borough of Florham Park, County of Morris, State of New Jersey in the previous one year, and that the contract will prohibit Best Gate & Fence of NJ, Inc. from making any reportable contributions through the term of the contract.

NOW, THEREFORE, BE IT HEREBY RESOLVED, by the Borough Council of the Borough of Florham Park in the County of Morris and State of New Jersey as follows:

1. A contract shall be entered into with the Borough of Florham Park and **Best Gate & Fence of NJ, Inc.**, for the Florham Park Community Garden Expansion Project. A Certification of Funds prepared by the Chief Financial Officer for this purpose is attached hereto.
2. The Mayor and Borough Clerk are hereby authorized and directed to execute an agreement with **Best Gate & Fence of NJ, Inc., 1275 Bloomfield Ave, Building 6, Unit 35, Fairfield, NJ 07004.**
